RATIONALE: To divide content between two existing courses in order to provide more depth and practice in each area.

Fundamental concepts of algebra; algebraic equations and inequalities; functions and graphs; zeros of polynomial functions; exponential and logarithmic functions; systems of equations and inequalities. Pr.: B or better in MATH 010; or two years of high school algebra and a College Algebra (Prob \geq C) of 60 or more on the ACT assessment by K-State; or a score of at least 18 on the mathematics placement exam.

RATIONALE: Change course title back to College Algebra.

Survey of current theories, techniques, and methodologies in adult TESL/TEFL provide a foundation for practical application in the classroom in GRAD 703, and GRAD 704. Topics of learning styles, course planning, identification of learning objects, and assessment of adult second/foreign language learners are incorporated into practical activities. Pr.: Graduate standing, or prior or concurrent enrollment with GRAD 703 or 704.

RATIONALE: The existing practica courses required for the MA in TEFL (Grad 702, 703, and 704) are each 2 credit classes. International students (the majority of the students in this track) need to be enrolled in 9 credits each semester by immigration regulations. Having classes of 2 credits each put students at 8 hrs, thus requiring them to take an extra 3-hr course in order to maintain their immigration status. By taking the three practica (total of 6 hrs) and dividing them into 2 3-credit courses, the problem of the nine-hour minimum to meet immigration status is solved.
